TERMS AND CONDITIONS:

1. Live Foal Guarantee shall pertain to mares that are pronounced safe in foal by a veterinarian within 90 days after the last breeding date. A live foal is defined as one that will stand and nurse. If the foal dies at birth, mare owner agrees to provide TNT Cattle Co Ltd within 7 days a veterinarian's certificate describing the occurrence. In such case rebreeding privileges will be available.

2. This agreement will expire no later than 2 years from the date of signing, or sooner if the contracted mare produces a live foal. If the breeding does not take place in the first year from signing a \$250 booking fee for the second year will come into effect. Non-use of the breeding, having a mare covered in the one year period from the date of purchase will conclude the agreement at which time the contract will expire.

3. Subject to the approval of Stallion owner, the mare owner may transfer this Breeding Agreement to another mare if the original contract mare dies or becomes unfit for breeding. A \$250 transfer fee and a written document from the mare owner's veterinarian that the original mare was not able to conceive and that it is recommended that the mare should not be rebred. The original termination date of this agreement will apply to transfers. This agreement is not transferable to any other mare owner without proper documentation in place, the approval of the stallion owner and a \$250 mare owner transfer fee.

4. If the above noted stallion dies or becomes unfit for service for any reason, then this contract will be null and voided both parties are relieved of any further obligation. Any monies paid by the mare owner toward the breeding fee, with the exception of the non-refundable booking fee that is included, shall be refunded to the mare owner.

5. TNT Cattle Co Ltd strongly suggests the mare be pregnancy checked by a veteran 15-30 days after the last breeding date.

6. **Mare owners veterinarian MUST contact Blue Sky Veterinary Services minimum one week before semen is requested to ensure timing and shipping details are worked out between the veterinarians, it is not the stallion owners responsibility. Stallion owner is not responsible for any shipping related issues.**

7. ** Mare owner MUST call Blue Sky Veterinarian and give credit card information for all shipping payments before collection date or frozen semen shipping.**
